FUNERAL & CEMETERY BENEFIT FOR DIOCESE OF DALLAS CLERGY AND EMPLOYEES

Effective: June 13, 2016

Intent

As leaders in the funeral profession, we take pride in providing the best services and products available to our families at their time of need. Clergy and employees of the Diocese of Dallas are eligible to receive discounts on cemetery property/merchandise and funeral services/merchandise.

Funeral/Cemetery merchandise and services may be purchased prior to time of need.

Application

These benefits are available only for merchandise and services purchased from and conducted in Dignity Memorial funeral homes. The funeral home properties are owned by Service Corporation International in the following Texas cities of Dallas, Carrollton, Richardson, Plano, and Frisco. The discount on Cemetery property is available only at the Diocese of Dallas Cemeteries, Calvary Hills Cemetery, Sacred

Heart Cemetery and Holy Redeemer Cemetery.

For at-need purchases, payment for any merchandise or services selected, including cash advance items,

if applicable, is required at the time of an at-need arrangement.

Discounts

Funeral arrangements that include a dignity savings should not exceed the total discount allowance.

I.e. Clergy and employees may receive the greater of (either Dignity or Diocese discount) given.

Service Area

If the death occurs outside the 30 mile service area of the selected mortuary, the benefit will begin once

one of the above mentioned facilities receive the deceased into their care.

For example- If a death occurs in another state, the person or persons responsible for handling the disposition of the deceased, will be responsible for any expenses incurred up until the deceased is transferred to a Dignity location in one of the cities mentioned above. At that point the discount benefit would be in force. This also includes preneed arrangements, unless the Travel Relocation Protection Plan

was purchased along with the preneed.

For preneed purchases, payment is dependent upon the payment method selected.
